The above deputation shall be governed by the following terms and conditions:

- The salary of these officials shall be drawn by the concerned DDO of Departments/Organizations as per the LPC issued by the concerned PSU/Corporation, without deputation/ deployment allowance;
- COLA/DA shall be paid at the rates, as being paid to them and the subsequent release of COLA/DA shall be applicable to them, as and when the same is released by the concerned Corporation/Organization;
- No arrears on account of pay or COLA/DA shall be paid in favour of these officials by the Government;
- 4. The salary in favour of these officials shall be released from the date they join duties in the Department/Organization;
- They shall retain lien in their parent PSU/Corporation/ Department;
- These officials are still on the rolls of PSU/Corporation and have not opted for Golden Handshake Scheme which shall be certified by the concerned organization;
- 7. The above arrangement shall be reversible without any notice.

Further, the deputation of these surplus officials shall also be governed strictly in terms of Circular instructions issued vide endorsement No. GAD/Acctts/Dep/Corp./2016 dated: 21.07.2016, read with Circular No. 15-JK(GAD) of 2023 dated 08.05.2023.
