- g) Disseminate information about the programme among various stakeholders for generating awareness (to be coordinated by the Information Department);
- Any additional information to be included in the template as may be critical to a particular District/Panchayat.

The Committee shall be serviced by the Department of Rural Development & Panchayati Raj.
