Subject: Apportionment of manpower between Union Territory of Jammu and Kashmir and Union Territory of Ladakh.

Government Order No. 24-JK(GAD) of 2024

Dated: 03-01-2024

WHEREAS, vide Government Order No. 1212-JK(GAD) of 2021 dated 15.11.2021 read with Government Order No. 505-JK(GAD) of 2022 dated 05.05.2022, Government Order No. 1257-JK(GAD) of 2022 dated 17.10.2022 and Government Order No. 468-JK(GAD) of 2023 dated 17.04.2023, **14,686** employees serving on substantive basis have been apportioned to Union Territory of Ladakh on the basis of options exercised by them and in terms of Section 89 of the Jammu and Kashmir Reorganisation Act, 2019;

AND WHEREAS, the Government Order No. 1212-JK(GAD) of 2021 dated 15.11.2021, further provided that the apportionment of remaining employees referred by the Union Territory of Ladakh shall be considered upon recommendations of Union Territory of Ladakh after due verification/ certification of their service records/ credentials by the latter;

AND WHEREAS, the General Administration Department, Union Territory of Ladakh vide communication No. A/95/2021-Secy-GAD dated 21.08.2023, after due verification of their initial appointment/ selection orders at its level also forwarded duly verified service records of 122 employees and recommended their apportionment to Union Territory of Ladakh;

AND WHEREAS, vide Order No. 390-LA(GAD) of 2023 dated 13.11.2023, the General Administration Department, Union Territory of Ladakh deputed Mr. Swami Raj, Section Officer and Mr. Mohd Shafi, Junior Assistant w.e.f. 15.11.2023 to 21.11.2023 along with relevant records for joint verification of records of the above employees recommended for apportionment to the Union Territory of Ladakh;
