Government Order No. 13-JK(GAD) of 2023 Dated: 04.01.2023

Whereas, amongst others, following three engineers of Power Development Department were repatriated from Union Territory of Ladakh to Union Territory of Jammu and Kashmir vide Government Order No. 1369-JK(GAD) of 2021 dated 27.12.2021, with the direction that they shall report in the Power Development Department, J&K after proper relieving by competent authority in the Union Territory of Ladakh:-

1. Mr. Ghulam Nabi Malik, Incharge Assistant Executive Engineer.

2. Mr. Ashraf Majid, Incharge Assistant Executive Engineer.

3. Mr. Sarfaraz Nazir, Incharge Assistant Engineer.

Whereas, the above engineers were not relieved by the Administration of Union Territory of Ladakh and, consequently, the matter was taken up with the General Administration Department, Union Territory of Ladakh, which vide communication No. A/95/2021-Secy-GAD-Part(2) dated 03.10.2022, conveyed that these engineers have not been relieved for want of their suitable replacements; and

Whereas, the matter was taken up with the Power Development Department and vide O.M. No. PDD-Gaz/95/2022-05 dated 17.11.2022, the department proposed deputation of substitutes in place of the above engineers to Union Territory of Ladakh along with a substitute for repatriation of Mr. Suraj Mani Sharma, Incharge Assistant Executive Engineer, who has completed a tenure of deputation of two years in Union Territory of Ladakh; and

Whereas, the proposal of Power Development Department has been considered by the Competent Authority in terms of Section 89(2) of the Jammu and Kashmir Reorganisation Act, 2019.

Now, therefore, in the interest of administration, sanction is hereby accorded to the repatriation of Mr. Suraj Mani Sharma, Incharge Assistant Executive Engineer presently working in the Union Territory of Ladakh to the Union Territory of Jammu and Kashmir with the direction to report in the Power Development Department, J&K for further posting after proper relieving by competent authority in the Union Territory of Ladakh;

Consequent upon the above, the following engineers of Power Development Department are hereby deputed to the Union Territory of Ladakh for a period of two years or till they are recalled. These engineers shall report in the General Administration Department, Union Territory of Ladakh for further posting and shall be entitled for incentives, as may be made available to such employees:-
